



This tour aims at the individualists, who prefer to visit the Baltic States and Scandinavia on their own. With the newly created E-Visa* you may easily enter the Leningrad Region. But, there are other issues that are easier handled in the group and with a tour operator.

The itinerary consists of the most important programmes: the water fountain park at Peterhof, the Amber Room at Pushkin as well as the Hermitage. The advantage here, as a group we do not need to queue as long to get in. A special highlight is the evening programme with folklore in the Nikolai Palace.

With more than 200 museums St. Petersburg is a cultural centre. There are museums about the arctic, about Dostoevski, showing musical instruments and even about vodka. It might be useful to extend your stay, especially since there are also concerts and ballets waiting for your visit.

During our stay we spend a few days in the western outskirts of St. Petersburg near Kronstadt or Peterhof and then move to a more central overnight place closer to the city.







Königsberg, as an Eastern Metropolis of Prussia, has always had a special status and for centuries has been an open political and cultural centre. Whilst the city took care of the spiritual growth, the countryside was breadbasket and treasure chest. Enormous fields, manors and stud farms and majestic forests, crystal lakes and wetlands cover the countryside between the small hamlets.

With the end of the war the area became part of Russia and all German remains were destroyed, new settlers arrived and villages were renamed. The Kaliningrad region was in a long sleep until the Perestroika. Today the neighbourhood with Poland and Lithuania is cultivated.

Three days of sightseeing programme leave culturally and scenically wonderful impressions. Two days are at free disposal for searching in the past, other discoveries or simply for relaxing. Departing via the Curonian Spit, the unique beauty of this wonderful headland can be admired. The farewell evening will be in Nida, the artist town on the Lithuanian side. From here everybody can discover the Baltic States according to own interests.

This tour was created when we were looking for a destination that is near, varied, interesting, not too overcrowded and quick to organize. Just the right tour to get started again after the winter season.

The river Lahn ranks only 22nd place in length in Germany. Still, the Lahn valley is very popular for friends of cycling, walking, canoeing or paddling. Travelling from Bad Ems, the Spa town often frequented by Prussian and European nobility, the tour quickly reaches the federal state of Hesse. Prior to the German Empire the Lahn valley was home to small dukedoms, whose rulers made it into several royal houses that still serve today.

Princes, bishops, famous poets and thinkers, as well as scientists and entrepreneurs wrote history that we can still see and explore. There are castles, cathedrals, historic old towns and some unique monuments for us to visit.

The scenery is not spectacular, but pleasant and gives the right frame to enjoy the time.



“White Nights in St. Petersburg” is one of our most popular trips to the former tsarist metropolis.

The tour begins in Malbork, continues into the Kaliningrad area over the Curonian Spit and through the three Baltic capitals, which you will get to know better during the city tours. The highlight of this trip is St. Petersburg with a four-day stay. Here you will not only see the Hermitage and the impressive Isaac’s Cathedral, but also visit the Peterhof Park and Pushkin with the Amber Room in Catherine’s Palace.

This route allows you to circumnavigate the Baltic Sea, including the areas of Russia less developed by camping tourism. From the Finnish border you can organize your own journey home. Alternatively, the Baltic States are also an interesting option for an interesting return journey.

Of course, we want to use the most experienced tour **staff** as effectively as possible. This means that when the catalogue is going to print, the respective tour leader will not be specified. Depending on the status of the bookings, this will only be decided in the course of further planning. Booked and reserved customers will of course be informed about the development of their tour.

You haven't found your **dream trip** in this catalogue? Take a look at our website. There you will find a complete travel list and also the possibility of making a non-binding reservation for future trips. In this way, you might be able to influence the next seasons programme.





If a trip begins or ends a little further away, as part of our service, we offer you a list of campsites and/or parking spaces, which you can use **to arrive** and/or **depart** with other participants or the tour escort, for example.

Our trips are designed in such a way that all important and interesting **sightseeing and programs** are included in the tour price. Only special interests such as ballooning, ballet or mountain hikes can occasionally be booked as an option and are paid for separately. We also include all services in the travel price that are identical for



all participants and are part of the process. So, on our trips you do not meet tour staff who collect additional amounts from the participants every day.

We think that **eating together** every few days on the trip brings the group together and thus contributes to a nice travel climate. 

Tour Preparation

In the catalogue, a **minimum number of participants** is specified for each trip, which must be available by a key date. 

Today the situation has changed and we have aids such as navigation devices and better maps. That is why we say: "Everyone is allowed, nobody has to". However, some participants appreciate the fact that they don't always have to worry about the route themselves, but can simply follow.

Travelling together connects people. It is therefore not surprising that many **friendships** have already developed among the participants and also with locals in the countries we visit on our trips. Some groups maintain regular contact even after more than ten years.

Depending on the region or operator, each camping unit is required to identify itself as a camper before being allowed to use a facility. The "Camping Key Europe" card, which is required for various trips, can be obtained through your local motoring club.

Some tours like "Moscow-St. Petersburg" or "White Nights" run every year. Other tours, often the longer ones, will be scheduled every second or third year only.

We decide in spring what tours are due in the following year. You may increase the chances of a special tour taking place by letting us know (without commitment) what tour interests you.

If you are set on a certain regular non-international tour, contact us for the possibilities to take place as an English language participant.

We have been travelling to Poland for decades, even if we have to admit that it was often just a transit country on the way east. We visited the Baltic Sea coast, Masuria, Silesia and the metropolises Warsaw and Krakow in sections every year, albeit briefly. This trip focuses intensively on Poland and is aimed at those who do not want to drive too long stages in beautiful and varied landscapes.

The Polish history from the Piasts and Prussians to the Jagiellonians and the union with Lithuania, the aristocratic republic to the various partitions: fascinating and impressive. German, Prussian and even Austrian pasts are presented on this trip, whether in pretty towns and villages, remote manor houses, mighty monastic castles or in the historical region of Galicia.



The German-Soviet joint venture "Perestroika" was established in 1990 between Minsk (USSR) and the Rettau family's campsite. The company built 6 campsites in the former USSR to open Western European travellers the "Gate to the East".

Soon the first Perestroika travellers arrived in small groups in the Soviet Union to meet the people and get to know their country and culture.

In 1992 tours went to Moscow, Leningrad, Yalta and Odessa for the first time. 1994 across the Ural to Lake Baikal, to the Silk Road - Tashkent, Samarkand and Ashgabat. Next to numerous short- and standard tours, the itineraries have become longer, and tours to Egypt, China, India and Singapore were added. Nowadays our tour programme still includes tours on three continents.

In 2012 the family business changed into the hand of the next generation and was renamed "Mir Tours".

From 2017 to 2020 Mir Tours operated tours to the Baltic States, St. Petersburg and Germany for the Camping & Caravanning Club from Great Britain.





Your Journey with Mir Tours

After receipt of the invoice, 10% of the travel price is due; for trips in cancellation categories B and C, a further 10% is due 55 days before the trip. The remaining payment must then be made 30 days before the start of the journey. Refer to the invoice for details.

We do not accept payment by credit card. You can find out from your credit card provider whether the insurance policies contained in the card contract are still valid.

You can make a non-binding reservation for trips in the next catalogue. You will then be given a date (which will allow sufficient time to study the new catalogue) by which you should confirm the option.

If you want to reserve yourself for a trip in the current catalogue, this is free of charge until the next information event. For long-term reservations, we charge a fee of 25 € per registration / unit, which you will be credited when booking. We donate unused fees to a children's home in Eastern Europe. The reservation is not yet a booking.

If a graduated price is specified in the trip, we first charge the highest rate. The calculation date is 10 days before the start of the journey. Based on the number of participants then booked, we will change the invoice and refund overpayments.

2) Documents / Visa

The following documents are required for all tours: passport, health insurance for travelling abroad, and break down cover.

Please, consider that in some consulates it takes about 4 weeks to obtain a visa. We need to have your original passport, with sufficient validity and blank pages.

Generally, the visa procurements for the respective trips are included in the tour price. The visas will be applied for by us - insofar as this is permitted by the consulates (due to global political events, changes in the visa procurement process may occur at short notice.). Because of the international politics at the moment (terrorist attacks, threats...) the regulations regarding the visa applications have become stricter. That means, that it could happen, that we are not able anymore to do the visa for you, because you have to go the embassy personally, e.g., USA. In that case we will still help you wherever we can.


1) Travel Application / Booking / Payments

At the travel date you will find the key date, the day on which we decide whether the advertisement has received enough bookings and can be carried out. In the best-case scenario, your binding registration should be received by us before this day. If we were able to make a positive decision for the trip and there are still places available, we can still accept bookings until the registration deadline.

If your mind is set on a certain tour, we advise that you book in time, as some tours are booked out only weeks after the catalogue is published. In case of an illness, the cancellation fees are refunded by the insurance company.

We are only allowed to process your booking once you have confirmed that you have read the documents form, travel conditions (pages 24,26 27) and additional information with your signature. This is done simply on the registration form. You can download the additional information from the respective page of the trip or request it from us.

After receipt of your written travel registration, you will receive the booking confirmation / invoice as well as the insolvency, travel cancellation including travel curtailment insurance certificate (attached to the Additional Information). These insurances are included in the travel price. Additionally, you will receive a schedule with the precise dates for sending in your passport, passport photos or other documents. It will also include other important facts about the trip and the required preparation, for example the date of the participants meetings prior to tour start.



Our price includes the cost for visa for EU-citizens, but for some foreign countries, there are additional costs for obtaining visa in foreign passports. This we will charge to you. If additional costs occur because you do not submit the required documents in time, these costs will also be charged to you.

3) Requirements

Some tours make high demands on people and vehicles. Health restrictions are not a problem for us, but when travelling to Eastern Europe you may not have the same accessibility. We kindly ask you to take into account that neither we nor other participants can assist you with medical or caring services. Since the possibility of travelling depends on the degree of your limitation, we advise you to take advantage of an individual, personal consultation with us before booking.

Generally, our tours can be done with all kinds of camper cars and caravans. However, vehicles with a low chassis are not suited for certain tours.

Vehicles with a length of more than 9m, a height of more than 3,3m and a weight of over 4,5 tons could be subject to local traffic restrictions and will be guided accordingly. Outside of Europe it might happen that they have to park in front of the overnight place at some locations because the entryways are too small.

We attempt to offer you pitches with electricity, water and sanitary facilities on all our tours (if not, you will be informed upon booking). Regardless, campsites outside of Western Europe will often have lower standards. Hence, we recommend to have at least a toilet in your vehicle.

The participants travel with own camper or caravan. For this reason, it is a requirement that you have a break down cover for all vehicles, including trailers.

Travelling abroad a Green Card from the insurance is necessary for all vehicles with a number plate (incl. the scooter in the garage). For trips outside of Europe you must request the cover to be extended by your insurance company. Alternatively, there is the possibility to buy a third-party insurance locally, however this will have a lower coverage.

4) Participants / Information Events

For some tours, there will be a participant meeting approx. about 8 weeks before the tour start. This is either in person or online. We will inform you in detail about itinerary, logistic, equipment and preparations of the tour you booked. Beside the information material, you will receive a list of participants, relevant notes and some useful hints.

In addition, we organize general information meetings several times throughout the year. In these you can participate to decide if a tour suits your needs as we will inform you about requirements and tour logistics prior to booking.

Please note: The Mir Tours Office and Burgstadt Camping in Kastellaun are situated only 20- 30 km from Frankfurt/Hahn Airport. Thanks to Low Cost Airlines this location can be reached with cheap fares from all over Europe.



5) Trip Cancellation

For every trip you will also find the key date. At this time, we have to decide whether the trip will take place or whether it has to be cancelled because the minimum number of participants is not reached. After this date - provided the trip takes place - you can continue to book until the registration deadline.

We notify booked customers of any changes in the status of the trip; this information can also be viewed on the homepage of our website.

You can withdraw from the trip at any time before the start of the trip, depending on which travel category you have booked, we will charge you the corresponding cancellation costs.

6) Pets

Pets are allowed on most tours, but should not impair the course of the trip. Some restaurants, museums, cathedrals or other public places do not tolerate dogs.

Also, it might be possible that for pets an admission fee is due at the border. Costs, which occur through pets will be charged to the owner.

All pets need an EU pet passport. Some countries require a certificate from an official veterinarian that should not be issued more than 10 days prior to the tour and depending on the destination your dog will need a rabies vaccination for the re-entry into the EU.

Some dog breeds are not allowed in some countries, e.g. hounds in Tunisia. Please check this prior to booking.

7) Mobility levels

We have to indicate the difficulty level for people with reduced mobility on every trip. This happens in three stages:

Level 1 - You walk mostly on flat terrain at a moderate speed. You should master Getting on / off the bus / train and simple stairs. (Suitable for rollators)



Level 2 - in addition to level 1, you have to manage on uneven paths (e.g. cobblestones, Gravel road) and some slopes



Level 3 - in addition to level 2, you need to be walking longer / more (e.g. hiking), also on hilly, steep terrain. You should be able to climb stairs (e.g. climbing a church tower)



8) General Information

Since our tour participants are **automobile tourists** driving themselves, the programme might change due to vehicle breakdowns, border

procedures, road conditions, force major or organizational reasons. Therefore, all tours and programmes are subject to change. The vehicles have to be in a good technical condition, all participants have to be able to cope with the challenges of the tour.

Because of the different approach locations of the parties, the **official beginning** of the longer tours mostly is abroad, e.g. in Poland, Hungary or Czech Republic. You will receive an information map describing the approach to a non-official meeting point in Germany/Austria/Switzerland to meet other parties for driving to the initial point of tour start. With very few exceptions, our trips begin in the evening (around 17:00) on the day of arrival and end in the morning (around 8:00) on the day of departure.

The time a **sightseeing** tour takes is different from town to town. Usually sightseeing tours last half-day, so the afternoon is off. Here generally a local bus and guide will take care of you. Some sightseeing trips en route done with the own vehicle are marked with a symbol (☞). Short excursions to points of interest nearby are not especially mentioned.

The tours offered in the brochure are all English language. It is possible that small number groups may be bi-lingual English and German. The tour leader will be fluent in both languages and may be of assistance with translating programme points.

If it makes sense, we use local public transport. Otherwise, we will order a suitable vehicle of our own for joint visits or transfers. The tour buses are usually of western standard, but outside the EU these are often less luxurious.

When **eating together**, we usually order a 3-course menu; on special occasions it can be a bit bigger. Sometimes there is just a snack because you have to try something special. Example: Fish sandwiches when visiting the Hamburg fish market - in this case we count that as half a meal for the services. We order juice or water with the menus. You will find a detailed list in the information folder for the participant meeting.

The **distances quoted** for driving kilometres is approximate values only. This might vary because of change in local infrastructure or because of the different speedometers in the vehicles. There are also diversions, changes in the stage ...

For standard **stages**, the tour guide makes recommendations: departure and arrival times, tolls, etc. Ideally, we leave at 9 a.m., but there are also exceptions, e.g. at border crossings and ferry crossings.

Campsite positions might differ in distance (max. 30 km) from the stated town. We quote the nearest known town, because maps available in Europe will then enable you to trace the route.

In countries with a camping infrastructure, we are generally on campsites in the 3-star category and better. Aire type pitches are only used if there is a special reason for this, e.g. Overnight at the winery after the wine tasting. In countries where there are no / hardly any campsites, we switch to so-called hotel parking spaces and stand in the parking lot, at a hotel, sanatorium, sports centre ... and use the sanitary facilities in the house, e.g. rent a shower room. In exceptional cases we have to stand for one or two nights free or without infrastructure, which is then also shown in the



travel advertisement. We try to ensure the basic supply of electricity, water, toilet and shower every day, but we cannot guarantee this.

You book a group tour so that you don't have to travel alone through the country. If you are driving together with the tour guide or other participants, a **CB radio** makes sense in your own interest. In the additional advertisement you will find a note about the urgency on the respective trip.

Pilot trips are so-called first-time trips, during which there may be changes to the program, routes and locations on site that were not known to us at the time of going to press and departure.

When booking a camping tour to Russia, Eastern Europe, Africa and Asia, you should be aware that you do travel to "camping underdeveloped regions". Hygiene, comfort and infrastructure are not as developed as in Western Europe. Also, our tours are not pure cultural tours - you should enjoy driving, be open minded and curious about other folks.

The **travel services** mentioned in the programme are included in the price. All other arising **costs** have to be paid by the participant, e.g. border- / toll- or custom fees, ferries, fuel, insurances, food, personal expenditure, tips or optional programs.

Should you take an **additional motorized vehicle** with you (automobile, motorcycle, boat,...) into a country that requires a visa, you have to inform us in time (latest at the participant meeting) because this might have to be noted in the visa and requires a green insurance card.

Please, remember that during some of the tours you are **no longer in Western Europe**, where travelling is much easier, for example no customs and borders. The countries of the former Soviet Union are dominated by poverty and economic difficulties and have an extravagant bureaucracy. On the other hand, you will become acquainted with people who are very hospitable and friendly.

In addition to the usual **border fees** like ecological fee, diesel fee and entry fee, we may opt to pay a service fee for a quicker dispatch.

For all trips with **ship passages**, weather-related changes in the timetable may occur at short notice.



TRAVEL TERMS & CONDITIONS

1. CONCLUDING A TRAVEL AGREEMENT

1.1 The following applies to all booking channels: This offer is based on the travel advertisement and the supplementary information from Mir Tours for the respective trip, provided that this is available to you when you book.

1.2 The following applies to bookings made orally, by telephone, in writing, by e-mail, SMS or fax:

a) With the booking (travel registration) you offer us the conclusion of the package travel contract.
b) You are responsible for all contractual obligations of travellers for whom you make the booking, as for your own, insofar as you have accepted this obligation by express and separate declaration.

1.3. The tour participants travel with their own outfit (tow-car and caravan) or camping car. This requires a valid safe-conduct pass (for home and abroad) for each participating vehicle. The insurance must include the caravan. For travelling abroad, an insurance is required, the green card. For travelling in Non-EU European areas (where the insurance green card is not valid), an extension of the insurance coverage must be requested and evidence of proof is to be offered when entering the respective countries. The vehicles must be in good technical condition and all the participants should be capable of managing the requirements regarding their stamina.

1.4. All bookings are accepted according to the date of receipt, although require our confirmation in writing. The travel agreement is concluded with our approval (booking confirmation).

1.5. Upon conclusion of the contract, or immediately after the conclusion of the contract, we will send you a travel confirmation in accordance with the legal requirements on a permanent data carrier (which enables you to keep the declaration unchanged or to save it so that it is accessible to you within a reasonable period of time, e.g. on paper).

1.6. If the contents of the travel confirmation differ from your booking, then we did not accept your application. Our changed offer is valid for 10 days. The contract is concluded on the basis of this new offer, provided that we have pointed out the change with regard to the new offer and have fulfilled our pre-contractual information obligations and you declare your acceptance by express declaration or deposit within the binding period.

1.7. The pre-contractual information given by us about essential characteristics of the travel services, the travel price and all additional costs, the payment modalities, the minimum number of participants and the cancellation fees (according to Article 250 § 3 Nos. 1, 3 to 5 and 7 EGBGB) are only then not part of the Package travel contract, provided this is expressly agreed between the parties.

1.8. For long-term advance bookings for tours still not published in a valid catalogue, the particulars from the actually valid catalogue (e.g. tours, dates, services, prices, as well as terms of travel and payment) are not binding. In this respect, your booking is not binding but rather optional.

2. RIGHT OF WITHDRAWAL

2.1 We point out that according to the legal regulations (§§ 312 Abs. 7, 312g Abs. 2 Satz 1 Nr. 9 BGB) for package travel contracts according to § 651a and § 651c BGB that were concluded at a distance (letters, catalogues, telephone calls, Faxes, e-mails, short messages sent via mobile communications (SMS) as well as radio, tele media and online services), there is no right of revocation, but only the statutory rights of withdrawal and termination, in particular the right of withdrawal according to Section 651h BGB (see also section 5). However, a right of revocation exists if the contract for travel services according to § 651a

BGB has been concluded outside of business premises, unless the oral negotiations on which the conclusion of the contract is based were based on a previous order by the consumer; in the latter case there is no right of withdrawal.

3. TERMS OF PAYMENT

3.1. We may only request or accept payments on the travel price before the end of the package tour if there is an effective customer money protection contract and you have been given the security certificate with the name and contact details of the customer money insurer in a clear, understandable and highlighted manner. A down payment of 10 per cent of the tour price per person is due and payable upon receipt of the security document sent to you with the booking confirmation. For tours that include visa a second 10 percent payment is due at least 55 days prior to departure. The remaining payment is due 30 days before the start of the journey, provided that the security certificate has been handed over and the right of withdrawal can no longer be exercised by us for the reason stated in Section 9.1. With the booking confirmation, you will be sent an invoice showing the amount of the down payments and the travel price.

3.2. If you do not make the down payment and / or the final payment according to the agreed payment due dates, although we are ready and able to properly provide the contractual services, have fulfilled our statutory information obligations and you do not have a statutory or contractual right of retention, we are entitled to withdraw from the package tour contract after a reminder with a deadline and to charge you with withdrawal costs in accordance with Section 6.3.

4. SERVICES AND PRICES

4.1. The contractual obligations are the descriptions and price statements of our programme, which are exclusively valid for the tour period.

4.2. Any third-party leaflets (e.g. local hotel leaflets) used for booking are only informational, without warranty for their contents.

4.3. As far as there is no different description of a tour in our catalogue, our prices include the fees for the camping locations during the tour offered.

4.4. The price is to be understood per person and refers to two persons per vehicle. Pets may be taken along, if this is possible according to the tour description. Any charges involving pets are to be paid by the owner.

5. VARIATIONS IN SERVICES AND PRICES

5.1. Individual tour service variations from the contractually agreed contents of the travel agreement becoming necessary after the agreement yet before the tour and that were not caused against our good faith, do not cause a deficiency and were not caused by ourselves are allowed as far as there are no considerable differences and changes and do not affect the entire character of the booked tour.

5.2. Possible claims remain undamaged as far as the changed services present shortcomings. If we had lower costs for the implementation of the changed trip or replacement trip with the same quality, the customer is to be reimbursed the difference in accordance with Section 651m (2) BGB.

5.3. We are obliged to inform you about changes in service immediately after becoming aware of the reason for the change on a permanent data carrier (e.g. also by e-mail, SMS or voice message) in a clear, understandable and highlighted manner.

5.4. In the event of a significant change in an essential characteristic of a travel service or a deviation from your special requirements, which have become the content of the package travel contract, you are entitled to a reasonable period set by us

at the same time as notification of the change

- either accept the change
- or free of charge from the package travel contract to resign
- or to request participation in a substitute trip if such a trip was offered.

You have the choice whether or not to respond to our communication. If you react to us, you can either agree to the change in the contract, request participation in a replacement trip, if one has been offered to you, or withdraw from the contract free of charge. If you do not respond to us or do not respond within the set deadline, the notified change is considered accepted. This must be pointed out to you in the declaration in accordance with Section 5.3 in a clear, understandable and emphasized manner.

5.5. We point out that many campsites we are visiting throughout the tour are not of the same standards you might be used to in Western Europe. Although we always try to only stop at high standard camping sites, there might be reduced standards in isolated cases concerning hygiene standards, sanitation/toilets, water quality and power supply. This does not represent any deficiency.

6. RESCISSION BY THE CUSTOMER

6.1. You may rescind from the tour at any time prior to departure. The withdrawal must be declared to us on a permanent data carrier.

6.2. If you withdraw before the start of the journey or if you do not start the journey, we will lose the right to the travel price. Instead, we can demand appropriate compensation if we are not responsible for the withdrawal or if exceptional circumstances occur at the destination or in its immediate vicinity that significantly impair the implementation of the package tour or the transport of people to the destination; Circumstances are unavoidable and extraordinary if they are not under the control of the tour operator and their consequences could not have been avoided even if all reasonable precautions had been taken.

6.3 The amount of the compensation is determined by the travel price minus the value of the expenses saved by the tour operator as well as minus what he acquires through other use of the travel services, which is to be justified by us at your request. We have set the following flat rate compensation, taking into account the period between the declaration of withdrawal and the start of the journey, as well as taking into account the expected savings in expenses and the expected acquisition through other uses of the travel services. The compensation is calculated after the time of receipt of the declaration of withdrawal as follows with the respective cancellation scale (percentage of the respective travel price):

Category A:

From registration up to 55 days before departure 10%
from 54 to 30 days before departure 20%
from the 29th to the 10th day before departure 30%
from the 9th day before departure 75%

Category B:

From registration up to 55 days before departure 10%
from 54 to 30 days before departure 25%
from 29th to 10th day before departure 35%
from the 9th day before departure 75%

Category C:

From registration up to 55 days before departure 10%
from 54 to 30 days before departure 30%
from 29th to 10th day before departure 40%
from the 9th day before departure 75%

6.4 In any case, you are allowed to prove that the reasonable compensation to which we are entitled is significantly lower than the required flat-rate compensation.

Form for informing the traveller on a package tour according to § 651a of the BGB

The combination of travel services offered to you is a package tour within the meaning of Directive (EU) 2015/2302.

You can therefore benefit from all EU rights that apply to package tours. The company Mir Tours & Services GmbH bears full responsibility for the proper implementation of the entire package tour.

In addition, the company Mir Tours & Services GmbH has the legally required protection for the repayment of your payments and, if the transport is included in the package tour, to secure your return transport in the event of its bankruptcy.

Mir Tours & Services has taken out insolvency insurance with R + V Allgemeine Versicherung AG, Raiffeisenplatz 1, 65189 Wiesbaden, phone 0611-533-0, email: ruv@ruv.de.

Most important rights under Directive (EU) 2015/2302:

The travellers receive all essential information about the package tour before the package travel contract is concluded (Article 250 §3 EGBGB). At least one entrepreneur is always liable for the proper provision of all travel services included in the contract.

The travellers are given an emergency telephone number or details of a contact point through which they can get in touch with the tour operator. The travellers can transfer the package tour to another person - within a reasonable period and possibly at additional costs.

The price of the package tour may only be increased if certain costs (e.g. fuel prices) increase and if this is expressly provided for in the contract, and in any case no later than 20 days before the start of the package tour.

If the price increase exceeds 8% of the package tour price, the traveller can withdraw from the contract. If a tour operator reserves the right to a price increase, the traveller has the right to a price decrease if the corresponding costs decrease.

Travellers can withdraw from the contract without paying a cancellation fee and receive a full refund of all payments if any of the essential elements of the package tour are changed.

If the entrepreneur responsible for the package tour cancels the package tour before the package tour begins, the travellers are entitled to a reimbursement of costs and, under certain circumstances, to compensation. However, the tour operator can withdraw from the contract up to 8 weeks before the start of the trip if fewer people than the required minimum number of participants have registered for the package tour.

In the event of extraordinary circumstances, travellers can withdraw from the contract without paying a cancellation fee before the start of the package tour, for example if there are serious security problems at the destination that are likely to affect the package tour.

In addition, travellers can withdraw from the contract at any time before the start of the package tour against payment of a reasonable and reasonable cancellation fee.

If, after the start of the package tour, essential components of the package tour cannot be carried out as agreed, the traveller must be offered reasonable other arrangements without additional costs. The traveller can withdraw from the contract without paying a cancellation fee if services are not provided in accordance with the contract and this has significant effects on the provision of the contractual package travel services and the tour operator fails to remedy the situation.

The traveller is entitled to a price reduction and / or compensation if the travel services are not provided or are improperly provided.

The tour operator assists the traveller if he is in difficulty.

In the event of the bankruptcy of the tour operator or, in some Member States, the travel agent, payments will be refunded. If the bankruptcy occurs after the start of the package tour and the transport is part of the package tour, the repatriation of the travellers is guaranteed.

In order for us to have your visa ready in time for your trip, we need a certain amount of advance notice. Therefore, the registration deadline is 45 days before departure.

In order to prepare yourself, your pet as well as your vehicle we offer information on the camping infrastructure in the travel countries, the various documents needed, details on visa procurement. There are many useful hints as well as specific offers for service packages and support on tour.

This book appears in a small edition, is updated regularly and if you are interested in an English version let us know.

6.5 We reserve the right to demand higher, individually calculated compensation instead of the above flat-rate compensation, provided that we can prove that the expenses incurred were significantly higher than the applicable flat-rate compensation.

6.6 If we are obliged to reimburse the travel price as a result of a withdrawal, the reimbursement must be made immediately, but in any case, within 14 days of receipt of the declaration of withdrawal.

6.7 Your statutory right, in accordance with Section 651e of the German Civil Code (BGB), to require us to notify you on a permanent data carrier that a third party should take over the rights and obligations of the package travel contract instead of you, remains unaffected by the above conditions. We must receive the declaration by the registration deadline.

6.8. We have insured you with the ERGO Reiseversicherung AG as part of a group insurance package including a travel cancellation and travel interruption insurance. You will be insured automatically upon booking. The insurance fee is included in the tour price. The insurance cover applies to resignation prior to the tour start or if you have to leave the tour for an insured reason. Upon booking, you will receive an insurance policy stating the conditions and further details. Extract / key data is found in "Additional Information".

7. REBOOKING

After conclusion of the contract, you are not entitled to changes in terms of the travel date, the travel destination, the place of departure, the accommodation or the type of transport (rebooking).

This does not apply if the rebooking is necessary because we have not given you any, inadequate or incorrect pre-contractual information in accordance with Art. 250 §3 EGBGB; in this case the rebooking is free of charge.

If, in the other cases, a rebooking is made at your request, we can charge a rebooking fee, which is determined as follows: 25 euro per person plus external costs already incurred.

8. UNCLAIMED SERVICES

If you do not make use of individual travel services that we were willing and able to provide in accordance with the contract for reasons that are attributable to you, you are not entitled to a proportionate reimbursement of the travel price, unless such reasons are not subject to the statutory provisions for free cancellation or entitled to terminate the travel contract. We will endeavour to reimburse the saved expenses by the service providers. This obligation does not apply if the expenses involved are completely insignificant.

9. CANCELLATION OF THE TOUR AGREEMENT

9.1. We can only withdraw from the package tour contract due to not reaching the minimum number of participants if we:

- have stated the minimum number of participants in the respective pre-contractual information as well as the time by which the traveller must have received the declaration before the contractually agreed start of the journey, and
- specify the minimum number of participants and the latest withdrawal period in the travel confirmation. Withdrawal must be declared to you at the latest on the day that was specified in the pre-contractual information and the travel confirmation.

If it becomes apparent at an earlier point in time that the minimum number of participants cannot be reached, we must immediately make use of our right of withdrawal.

9.2 If the trip is not carried out for this reason, we have to reimburse your payments to the price of the trip immediately, but in any case, within 14 days of receipt of the declaration of withdrawal.

9.3 We can terminate the package tour contract without observing a notice if you persistently disturb the peace of the tour or willfully misconduct yourself after having been pre-warned. This does not apply if the behaviour contrary to the contract is caused by a violation of our information obligations. If we cancel, we retain the right to the travel price; however, we must offset the value of the saved expenses as well as those advantages that we gain from using the unused service for other purposes, including the amounts credited to us by the service providers.

10. INDEMNIFICATION, LIMITATION OF LIABILITY

10.1 Our contractual liability for damage that is not personal injury and was not culpably caused is limited to three times the travel price. Any further claims under international agreements or statutory provisions based on such remain unaffected by the restriction.

10.2 We are not liable for service disruptions, personal injury or property damage in connection with services that are only brokered as third-party services (e.g. arranged excursions, sports events, visits to the theatre, exhibitions) if these services are expressly stated in the travel advertisement and the travel confirmation and stating the identity and address of the mediated contractual partner have been clearly marked as external services so that they are not recognizable to you as part of our package tour and have been selected separately. The §§ 651b, 651c, 651w and 651y BGB remain unaffected. However, we are liable if and to the extent that your damage was caused by a breach of our notification, clarification or organizational obligations.

11. PILOT TOURS

Pilot tours are trips where we visit new territory and where it might become necessary to make changes to programmes, routes or places that were not known upon printing the catalogue. This might be because roads, overnight places or borders are unexpectedly and suddenly not in service. Due to this unique difficult character, the tour price is subsequently reduced.

12. OBLIGATION OF CO-OPERATION

12.1 Travel documents

You have to inform us if you do not receive the necessary travel documents (e.g. passports) within the notified period.

12.2 Setting a deadline before termination

If you want to terminate the package tour contract due to a travel deficiency of the type described in § 651i Paragraph 2 BGB, if it is significant, according to § 651l BGB, you have to give us a reasonable period of time to remedy the situation. This only does not apply if we refuse to remedy the situation or if immediate remedy is not necessary.

12.3 Notification of defects / request for remedy

If the trip is not provided free of travel deficiencies, you can request a remedy. If we were unable to remedy the situation as a result of a culpable failure to report defects, you can neither assert claims for a reduction in price according to § 651m BGB nor claims for damages according to § 651n BGB. You are obliged to notify our local representative of your notification of defects immediately. If a representative is not available on site and is not contractually owed, we must be informed of any travel defects; The participant folder will inform about the availability of the tour operator's representative. Our representative is instructed to take remedial action if possible. However, he is not authorized to recognize claims.

13. EXCLUSIONS OF CLAIMS

According to article 651g German Civil Code, you have to assert your possible claims for warranty or

indemnification (§§ 651c to 651f German Civil Code) immediately after the contractually stipulated end of the trip with us. For reasons of evidence security, this should be transmitted on a durable medium. You can only assert claims later if you were prevented from reporting immediately through no fault of your own.

14. AIR CARRIER

The EU regulation on informing passengers about the identity of the operating airline obliges us to inform you about the identity of the operating airline of all air transport services to be provided in the context of the booked trip when booking.

If the operating airline has not yet been determined at the time of booking, we are obliged to give you the name of the airline or airlines that are likely to operate the flight or flights. As soon as we know which airline will operate the flight, we need to inform you.

If the airline named to you as the operating airline changes, we must inform you of the change. We must immediately take all reasonable steps to ensure that you are notified of the change as soon as possible.

15. PASSPORT, VISA, CUSTOMS, FOREIGN EXCHANGE, HEALTH AND INSURANCE REGULATIONS

15.1.

We will inform you about general passport and visa requirements as well as health formalities of the country of destination including the approximate deadlines for obtaining any necessary visas before the contract is concluded and any changes to them before the start of the journey. In the case of special features (e.g. dual citizenship, statelessness), we will use your help.

15.2 You are responsible for procuring and carrying the travel documents required by the authorities, any necessary vaccinations, compliance with customs and foreign exchange regulations, and compliance with aspects of insurance law. Disadvantages that arise from not following these regulations, e.g. the payment of cancellation costs are at your expense. This does not apply if we have not, inadequately or incorrectly informed you. The traveller is solely responsible for the legal obligation regarding insurance.

15.3. The tour operator will assume the procurement of visas if this is permitted by the consulates. Your passport must be sufficiently valid after termination of the tour. Without handing over all required documents (passport, passp. photograph) before the date specified, we are entitled to charge you for the additional cost. We cannot be held responsible for the timely procurement through the consulate, unless the delay is due to our neglect.

16. REFERENCE TO EGBGB (DATA PROTECTION)

All personal data that you provide to us to process your trip will be saved and used by us insofar as this is necessary for the execution of the contract. 
